## From the Vice President for Administrative Services, Sean Poellnitz:

### FACILITIES

- Final preparations on 8 faculty offices; assisted new faculty with office move-ins; final classroom preparation
- Emergency manager, PIO and Facilities attended Active Threats preparedness training together and worked on tabletop scenarios.
- Assisted in relocating Inclusion, Advocacy & Community center back into their center in preparation for their grand re-opening.

### FINANCE

- Re-engaged in FY22 audit with pulling detailed documents for testing, working with audit agency, Davis Farr, to ensure bank reconciliation and trial balance are aligned for testing
- Supported Kodiak Corner Enrollment during the first few days of classes, answering questions for students
- Reviewed and selected student payment plan vendor (Nelnet) and collections agency (AAI). Currently reviewing contracts for implementation

### HUMAN RESOURCES, COMPLIANCE AND PAYROLL

- **Hiring and Staffing**  
Human Resources supported the successful onboarding of **11 full-time faculty and staff** and **25+ student/hourly employees** across multiple departments in September. Recruitment continues for several key vacancies, with active searches in Student Success, Administrative Services, Student Learning and Inclusion Advocacy & Community.
- **Compensation and Benefits**  
Preparations are underway for the **annual Open Enrollment period (October 27 – November 24)**. HR is training Benefits Administrators and developing communications for employees and their families.
- **Performance Evaluations**  
Planning has already begun for the **2025–26 cycle**, with a focus on improving compliance and consistency in goal setting and feedback.
- **Training and Development**  
The College will launch **mandatory compliance training for faculty and staff** on **October 7, 2025**, through the Vector Solutions platform. This rollout includes modules on FERPA, Title IX/Clery, Ethics, Workplace Violence Prevention, Hazing Awareness, and Preventing Harassment and Discrimination.

### INFORMATION TECHNOLOGY SERVICES

- In collaboration with the Student Onboarding Team, renamed the “Cascadia Network Account” to “Kodiak Account” for easier reference across campus.
- Prepared 50 new laptops for student lending; 130 were checked out in the first week of fall, with 192 now on loan.
- Implemented automated software updates for non-Microsoft applications, greatly improving Cascadia’s information security posture.

## **From the Leadership Team for Student Learning, Dr. Erik Tingelstad & Shannon Bath:**

### **Computer Science:**

After several months of planning, Dr. Brian Bansenauer submitted an NSF-ATE grant proposal for review. The project is titled “Cascadia Computing Pathways: Bridging High School to Tech Careers through Mentorship, Alumni Engagement, and Applied Learning.” It would run for three years at just under 1 million dollars. Computer Science faculty Mike Panitz, Justin Carlson and Anna Batra assisted. Feedback should be received by January.

### **Sustainability:**

Cascadia featured a booth describing our campus elements and sustainable practices at City of Bothell's City Hall festival, Sustainamania. Staff (Stephan Classen) engaged with over 40 members of the public about our campus grounds, wetland and trail connections, and accessible education.

### **CCF/Math:**

State Board staff met with Cascadia CCF and Math faculty (Erica Almeida, David Dorratcague and Megan Luce) as well as advisors (Gordon Dutrisec and Wenli He), on October 2<sup>nd</sup> as part of a listening tour around the system. The purpose was to learn more about the pathways that exist for BEdA students to transition into pre-college and college level math courses.

### **Natural Science/STEM:**

Faculty, student team members, and staff will attend the Fall Convening of the STEM Transfer Partnership STP 2.0 as part of our continued participation in the community of practice led by the Community College Research Initiatives program. We are pleased to include two students: Shaanvir Buttar and Maxim Medveditskov, both engineering students.

### **Opening Week for Faculty:**

The response to the offerings by the Teaching and Learning Academy during faculty sessions of Opening Week and the session on Deescalation led by Rosemary Simmons was enthusiastic; the workshops were timely. Faculty were also introduced to Watermark's Assessment software that streamlines student artifact rating and creates dashboards of the results for easier analysis. Faculty also began the norming process to assess our college-wide learning outcomes.



## From the Vice President for Equity & Inclusion, Chari Davenport

**Inclusion and Advocacy Center** – We had a successful Open House for the Center re-opening on Wednesday, October 1, with a wonderful ribbon cutting ceremony, celebratory cake and treats, and an engaged groups of visitors as we welcomed folks into our renovated space. All feedback was positive and many noted how much ‘lighter’ the room seemed. This is due to the new light blue walls, and repainted white ceiling – this truly opened the space. The biggest (and most exciting for me) is the new doors. Our new doors mirror the entrance to Mobius and now we are able to leave the doors open while we are present; which creates a true welcoming environment for all of our visitors – reinforcing our vision that ‘We are Stronger Together!’

There are several workshops and events happening weekly in the Center. Please review our next newsletter for details.



### Cascadia Scholars –

- We currently have 84 Scholars. We have completed several rounds of application reviews and there are more to come. In addition, we have 24 mentors with three who recently joined our team of student supporters.
- We had a great presence at Jumpstart on 9/18 and 9/19, sharing with nearly 200 students about the Scholars program and distributing promotional materials
- We have also attended several College 101 classroom visits, as well as an outreach visit to the IP Orientation to promote both the Center and the Cascadia Scholars Program
- We have added four new mentors and are always on the lookout for more
- For Fall programming, we have planned several welcome orientations:
  - Tuesday, October 7<sup>th</sup> (in person)
  - Thursday, October 30<sup>th</sup> (in person)
  - Tuesday, November 18<sup>th</sup> (virtual)

**Foundations of E&I** - We will have a total of 15 people taking the fall cohort (12 Cascadia employees and three are from the UWB Library). With this larger number – there will be two groups. We are very excited to once again offer this valuable opportunity for our Cascadia community.

## **From the Vice President for Student Success Services, Erin Blakeney**

### **Leadership & Recognition**

## **5. Information Items**

### **A. Risk Register**

VP Poellnitz discussed the list of risks identified for the College

In this year's assessment, there were no adjustments to the current list of risks. Two new risks were added due to the current administrative climate.

B. International Programs- Decline in international student programs enrollment

Mitigation plans are in process for the above identified risks.

### **B. Policy Homework Overview**

President Murray reviewed the policy review process. The Board reviews and approves the viability of 1/3 of the Board Policies each year. The assignment is given every September with a due date of the November Board Meeting. This year, the Board is asked to review Articles 1. Instructions and a worksheet will be sent after the Board meeting.

### **C. Accreditation Update**

President Murray discussed the presentation included in the packet to update the Trustees as Cascadia approaches the end of its 7-year accreditation cycle. This year (2025-26) is considered Year Six when the college's Standard 2 Report is due. This report covers college "Governance, Resources, and Capacity."

### **D. 2025-26 Strategic Plan Initiatives**

The Strategic Plan is an evolving set of initiatives within the three pillars of the college's work: Equity, Access, and Superior Learning. Each year, initiatives are sunset (finished and wrapped up), become operational or are kept on-going.

The presentation included in the packet details the status of the initiatives as we move from 2024-25 to 2025-26. Note that these initiatives are revisited throughout the year during monthly Board meetings as Mission Fulfillment Moments when we analyze them in more detail with accompanying data.

## **6. Discussion & Presentation Items**

### **A. Mission Fulfillment Moment: UWB Transfer Report**

Erin Blakeney introduced Michael Horn, who provided a brief overview of the Transfer Update Data Slide Deck included in the packet. Key highlights included:

- Strong transfer intent: Among Cascadia students, transfer intent remains high, with the percentage of full-time students indicating transfer goals continuing to rise over time.
- Highest yield rate to UW Bothell: Cascadia consistently achieves the highest yield rate for UW Bothell, meaning a greater proportion of admitted Cascadia students choose to enroll. This reflects both Cascadia students' commitment to UW Bothell and the strong support provided by UW and Cascadia staff to facilitate enrollment.

### **B. Year-in-Review: Inclusion, Advocacy, and Community**

Chari Davenport presented the IAC's 2024–25 Slide Deck, included in the packet. The discussion highlighted continued growth across several programs, including:

- Cascadia Scholars
- Diversity & Equity Center
- Foundations of E&I Course
- Student of Color Conferences
- Affinity Groups

### **C. Title IX Regulations Rules Adoption**

Ellen Evans, AAG, reviewed the process the Trustees will follow for voting:

April 2024, the Department of Education issued a Final Rule amending the Title IX regulations. Cascadia implemented rules in compliance with those amendments in January 2025. That same month, a federal court issued a decision vacating the 2024 Final Rule, which meant that Institutions of Higher Education must comply with the 2020 Amendments to the Title IX Regulations. Cascadia began the rulemaking process to repeal WAC 132Z 119, which complied with the 2024 regulations, and adopt WAC 132Z-120 which aligns with the 2020 Amendments. These rules were first reviewed by the Board of Trustees on March 19, 2025.

Following the required rulemaking process under the Administrative Procedure Act, Cascadia filed a CR-101, published in WSR 25-09-066, and a CR-102, published in WSR 25-

13-083. A rulemaking hearing was held on August 5 at 2pm. No comments were received, and no changes were made to the rules as initially proposed.

### **C. Cascadia Classified Union (WPEA)**

Ryan Higgins provided the Board with an update on recent developments:

- OFM-WPPA Contract: A new tentative agreement between OFM and WPPA includes a 3% and 2% COLA, with back pay effective in July. The contract was sent out for a vote, and members approved it. The Head of OFM will determine the feasibility of the agreement; if feasible, it will move forward to the legislature for budget recommendation. If not feasible, bargaining may resume.
- Parking Rates: No decision has been made yet.

His vision to “create inclusive, hands-on learning environments that inspire students to pursue STEM with confidence and curiosity” aligns with Cascadia's mission to serve our diverse students with CUREs support and other active learning lab practices. Beyond the lab, he brings the same curiosity and energy to his personal life, whether following baseball, reading science fiction and fantasy, or finding inspiration outdoors through kayaking and hiking.

#### Anna Batra, Tenure track Computer Science Faculty

Anna is our new tenure track Computer Science faculty; she has been teaching at Cascadia for the past year. Her undergraduate degree is in Linguistics with minors in Mathematics and Data Science. She then continued her studies with an MS in Computational Linguistics, all from the University of Washington (UW). At the UW, she spent three years as a Teaching Assistant, Head Teaching Assistant, and Lecturer. Her Computing Education research focused on Accessible Design in CS Education and Student Attitudes and Expectations in CS Education. Anna has expressed interest in student activities and finding ways to engage CS students outside of the classroom.

#### Dr. Justin Carlson, Computer Science Faculty

Justin is also coming to Cascadia as a new Computer Science faculty member in the Fall. Justin is most recently from industry, where he spent most of the past 15 years as a Software Engineer at Google and then Aurora Innovation, where he worked on the development of an autonomous driving system. He earned his BS in Computer Science from the University of the Pacific and later earned his Ph.D in Robotics from Carnegie Mellon University (CMU). There, he worked briefly as a teaching assistant and then had the opportunity to be part of a team that launched a satellite campus of CMU in Qatar. There, he taught classes and was involved in high school outreach, coordinating BotBall and programming competitions.

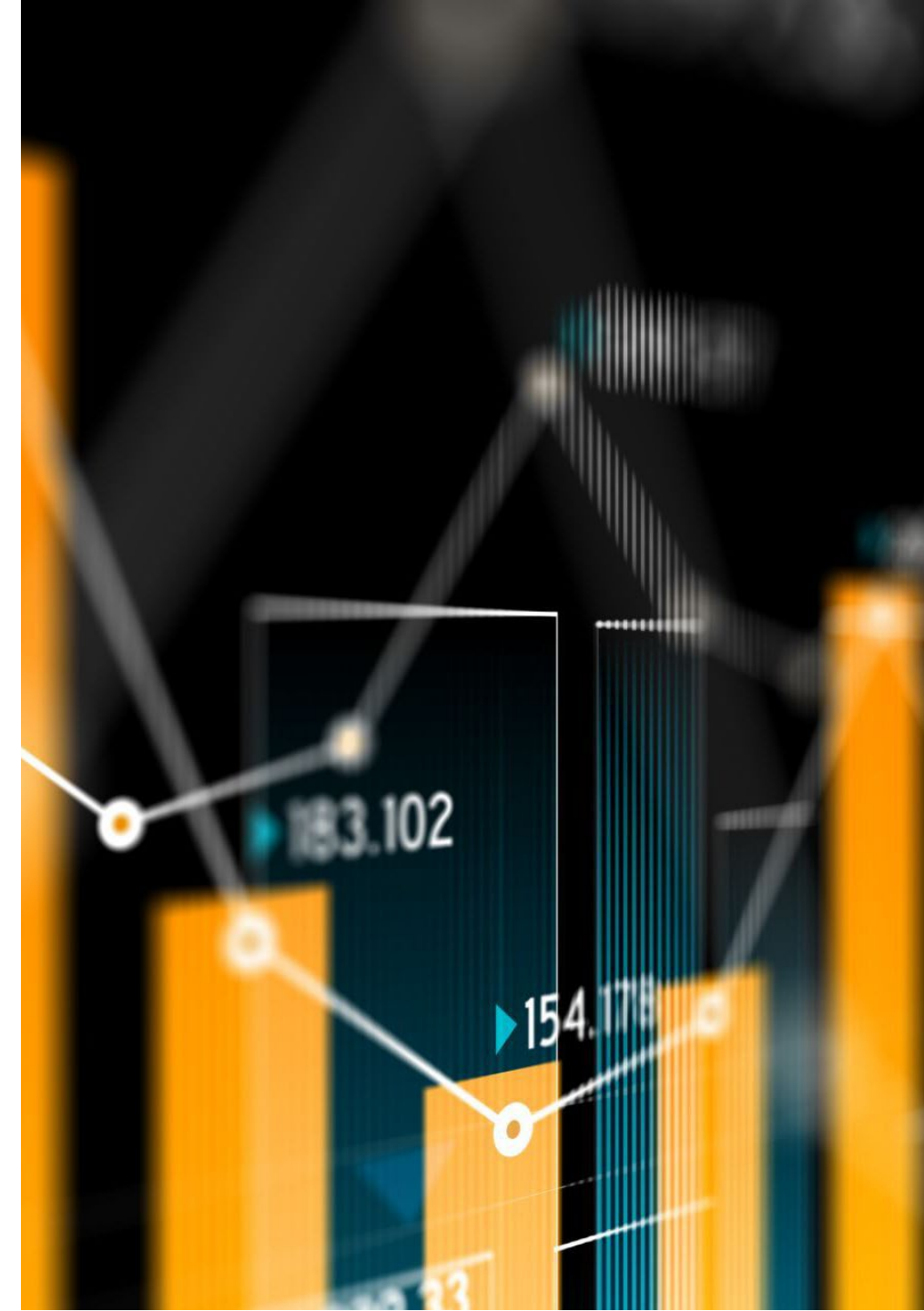

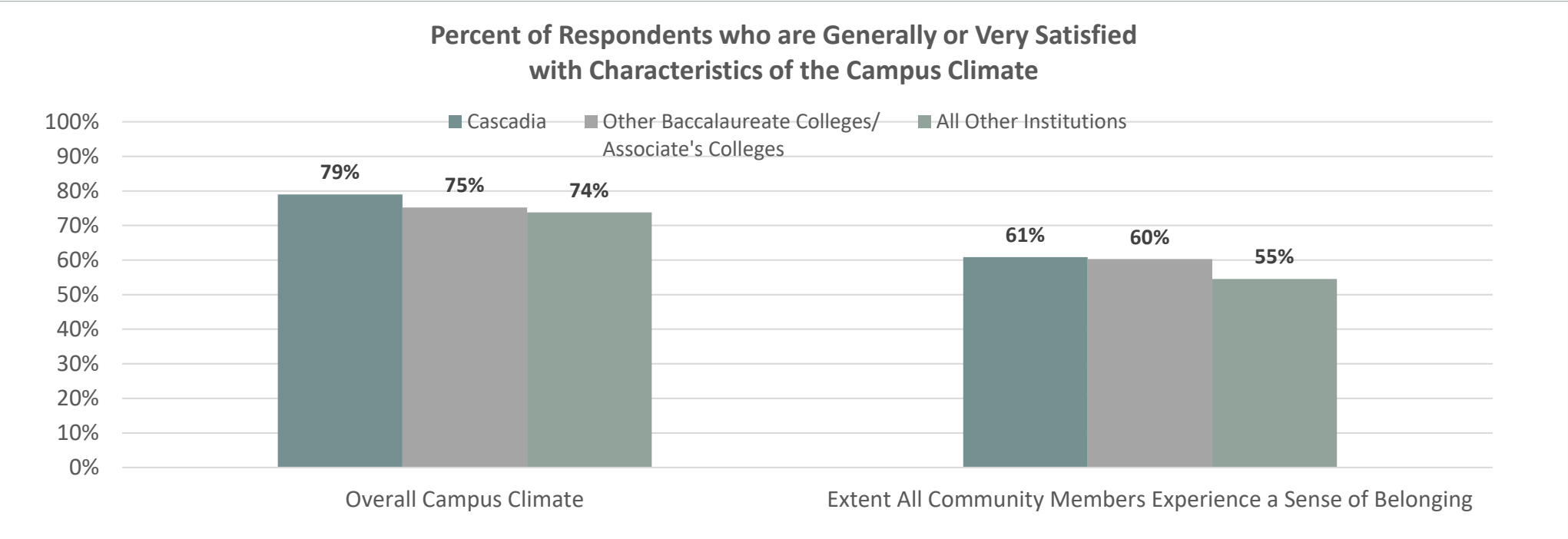

Exhibit 1. Indicators for Sense of Belonging, benchmarked against other institutions, reported since 2023



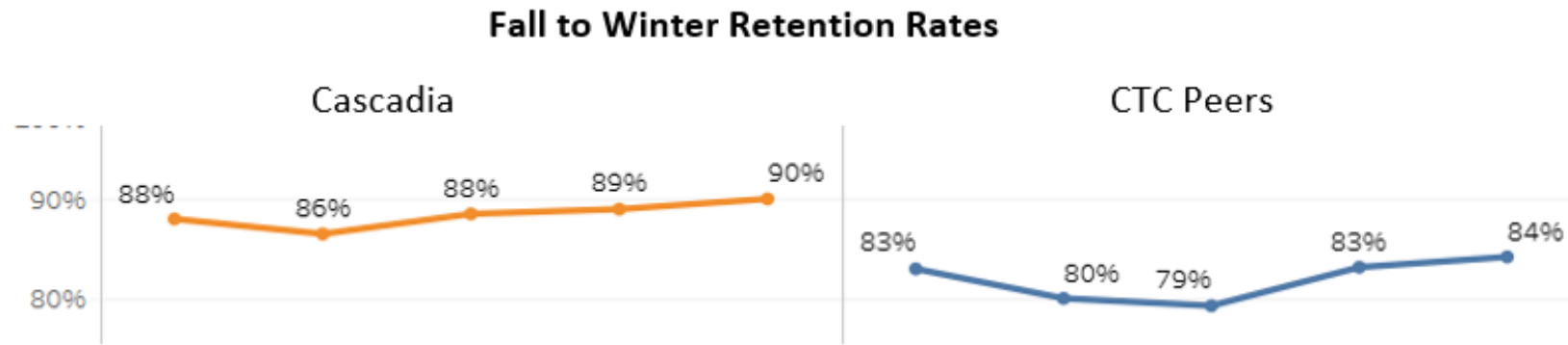
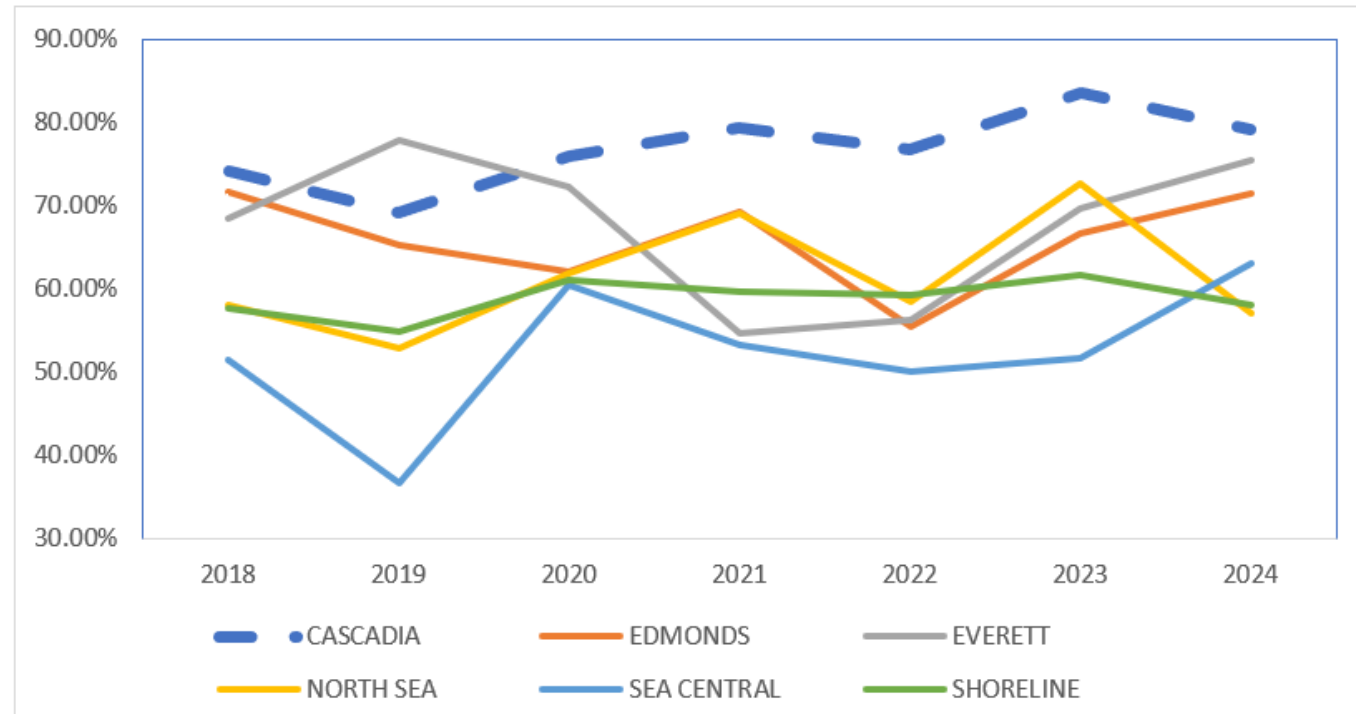


EXHIBIT 2. INDICATORS FOR FALL-WINTER RETENTION,

## Board-Level Summary: 2025 Cybersecurity Update

---

### ❑ Zero Major Breaches / System Resilience:

- Cascadia College achieved *zero significant cybersecurity incidents* in 2025 while maintaining *>99.9% uptime* across all critical systems; demonstrating enterprise-level reliability and proactive defense posture.

### ❑ Operational & Cultural Strength:

- The IT Security Operations team, staffed by certified professionals, implemented *10 of 11 recognized layers of defense*, positioning Cascadia among the top-performing institutions statewide.
- Faculty and student phishing-report engagement has significantly improved, reinforcing a *college-wide culture of cybersecurity vigilance*.

### ❑ Strategic Alignment & Next Steps:

- Expanded collaboration with the *State IT Commission* and vendor partners enhanced intelligence sharing and resilience planning.

# Current Threat Landscape



Higher education institutions remain high-value targets for cybercriminals due to decentralized access systems, sensitive research data, and broad user populations. Based on our 2025 threat analysis, the top risks include:



1. Phishing and Social Engineering: Attempts to compromise faculty, staff, and student accounts.



2. Ransomware Attacks: Growing in sophistication, often targeting institutions with limited MFA coverage.



3. Credential Theft: Exploiting weak or reused passwords.



4. Endpoint Vulnerabilities: Risks associated with unmanaged or personal devices. 5. Third-Party Vendor Risks: Particularly in cloud services and student-facing platforms.

**Our college compares strongly against peers across the system. Based on the January 2025 IT Commission benchmark.**

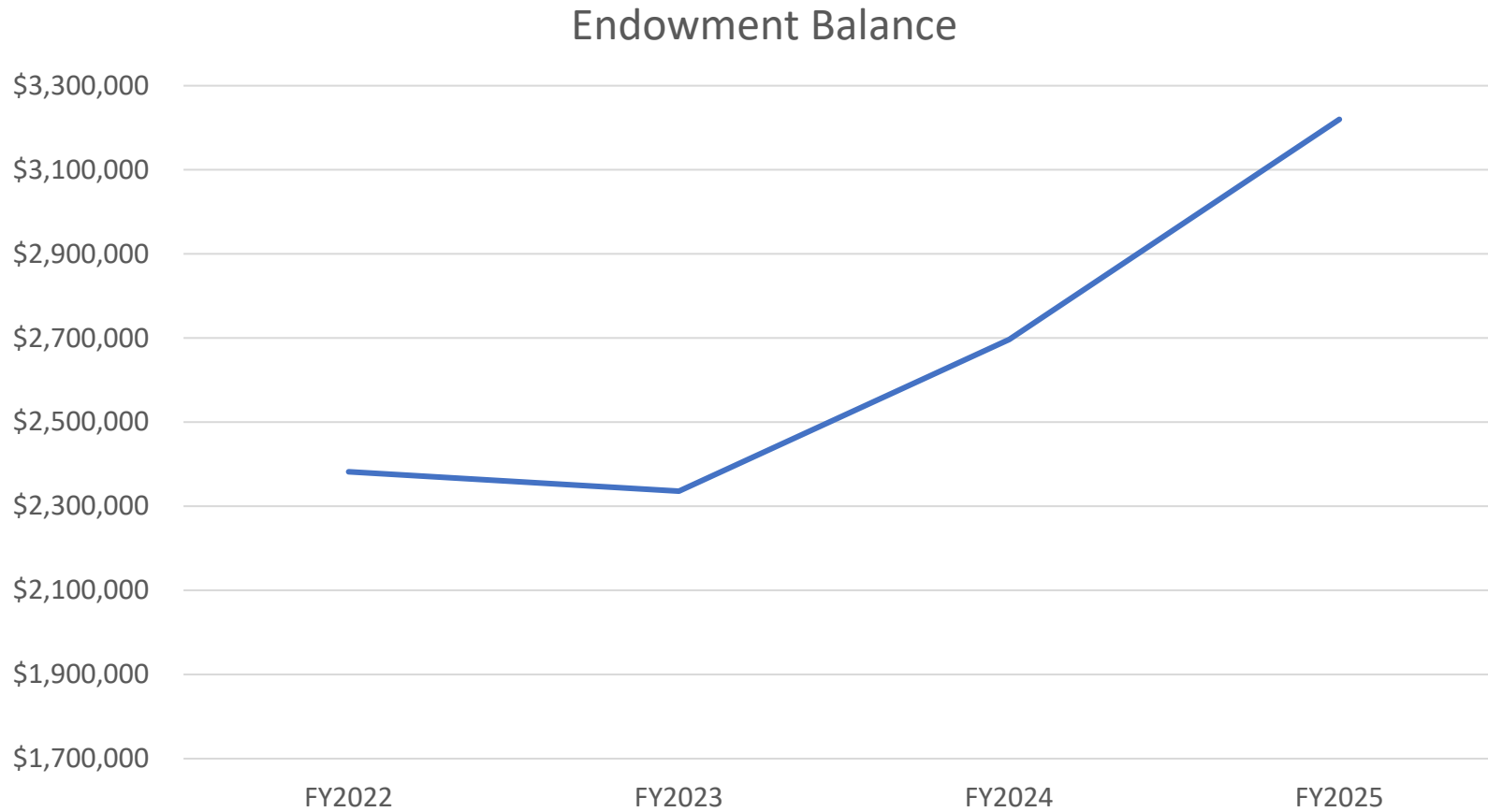

# 2025-26 Program Funding Allocations

The Foundation is proud to support the following Cascadia College programs to best serve our students:

## **Foundation Scholarships**

\$134,200 – Scholarships for Cascadia students disbursed throughout the year, each ranging from \$1,000 – \$5,500.

## **Emergency Grants**

\$70,000 – Funding to help students who need support with utilities, transportation, medical bills, childcare, and/or food.

## **Cascadia Scholars**

\$60,000 – Scholarships for students enrolled in the Cascadia Scholars program, designed to serve underrepresented students.

## **Kodiak Cave Food Pantry**

\$20,000 – Support for students with food insecurities (demand for the campus food pantry grew over 28% this past year).

## **College & Career Foundations (CCF)**

\$30,000 – Rosa Pielle Memorial Scholarships, math support, and transportation assistance for CCF students.

## **International Programs (IP)**

\$46,000 – Scholarships for International & Study Abroad students as well as funds for IP events & outreach activities.

## **Running Start**

\$10,000 – Textbook funding assistance to ensure Running Start is more accessible to students who qualify.

## **Complete Your Dreams/PT Scholarships**

\$7,500 – Scholarships to support students working part time or within 15 credits of graduating from Cascadia.

## **Faculty & Employee Awards and Prof. Dev.**

\$8,707 – Funds Cascadia’s annual faculty and staff awards and faculty professional development.

## **President’s Discretionary Fund**

\$5,000 – Funds hospitality and outreach that enhances community engagement on and off campus.
